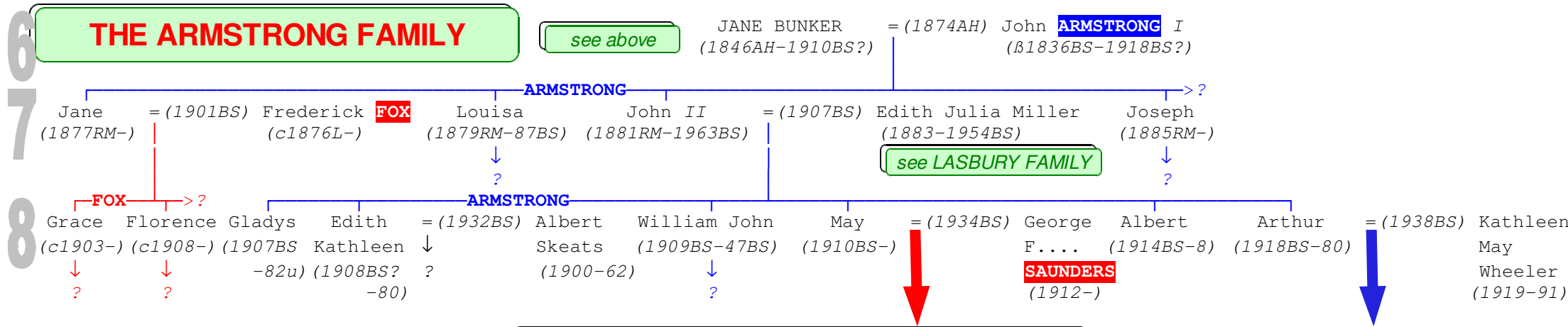

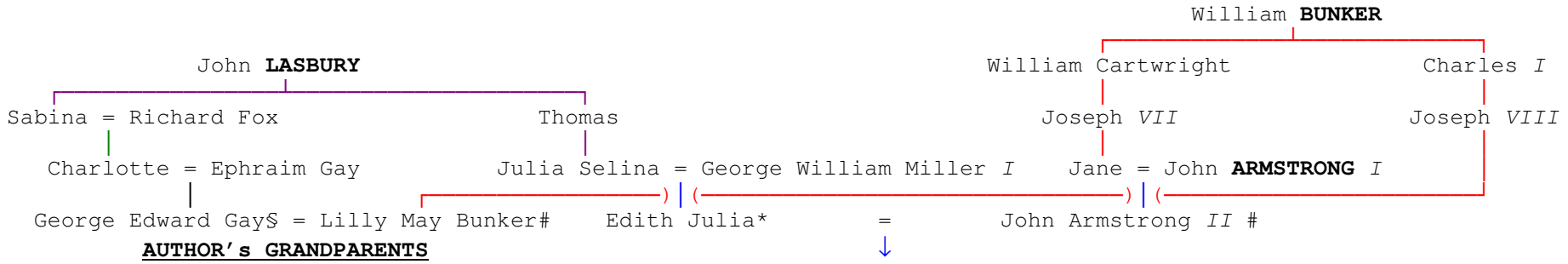

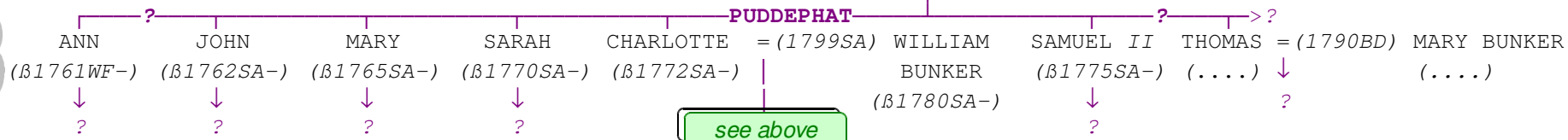
RELATIONSHIPS BETWEEN THE AUTHOR'S GRANDPARENTS AND THE ARMSTRONG FAMILY



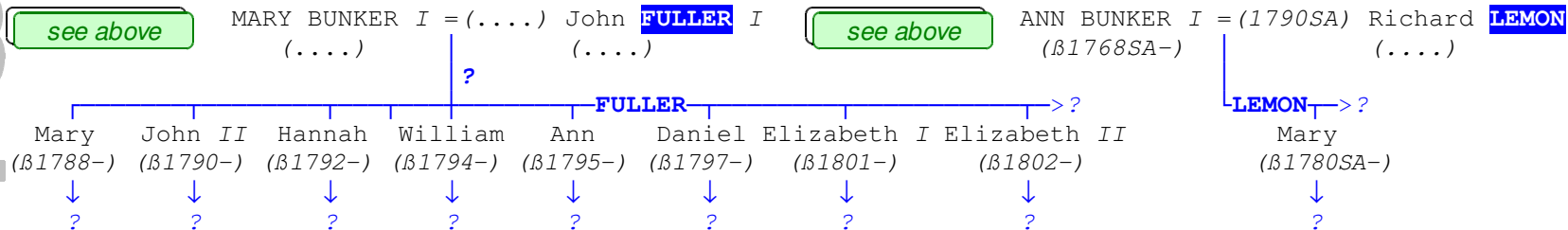
