Workshop Description

The workshop on "**Investments, Energy, and Green Economy**" aims at bringing together researchers at the forefront of research on economic decisions in dynamic models and in models under uncertainty and irreversibility for discussing new developments and applications in Energy and Green Economy. Accordingly, we solicit both theoretical and applied contributions addressing, with an emphasis on microeconomic analysis, issues related to:

- Reversible and irreversible investment choices in the presence of competing energy (e.g. grey and green) technologies
- Diffusion of energy technologies and the role of uncertainty in investment decision problems
- Strategic adoption of technologies and switching of energy sources
- Derivatives on energy markets, weather derivatives
- Electricity storage systems: optimal management and economic impact
